### 48/19 QUESTIONS FROM PARISHIONERS

A resident asked if the Parish Council had any further information regarding the recent application for stabling near to the Ford on the road opposite to the Forge pub. The Planning department had visited the site and he understood the work was on hold. The Chairman stated that nothing further had been received to date however, the Parish Council had not objected.

#### **49/19 MINUTES**

Members were asked to approve the minutes of the Parish Council meeting held on 18 November 2019.

Further to Minute 40/19, it was reported that nothing further had been received from the Police regarding the suggestion for a speed watch scheme in the village.

Another car had gone through a hedge about two weeks ago in the middle of the afternoon.

### 50/19 **CORRESPONDENCE**

### (i) Ulgham Meadows Land

The Chairman reported that the purchase of the meadows land had been completed and the legal documents had been signed, witnessed and returned. The dispute regarding the fencing of the land had been resolved. The Chairman had spoken to the owner of the neighbouring land and he is willing to discuss this further with the Parish Council as the land was not suitable to allow access for fencing at the present time. The Council needs to find out what he wants in terms of type of fencing before tenders can be sought.

# (ii) Update re haul road

The Chairman had written to NCC asking for an update regarding the restoration of the haul road.

A response had been received and was summarised for the benefit of the meeting. The land had been sold to a local company at the end of the summer and therefore NCC were not in a position to take enforcement action against the previous owner. The current owners were aware of previous enforcement action and had agreed that the haul road wouldl be restored and

that it was urgent given previous delays. It was understood that the current owner intended to produce a revised scheme which would be subject to the approval of NCC.

The agent for the owners has been contacted recently by NCC in order to understand their intentions and if they were not satisfied with their timescales, they would consider what further action to take.

RESOLVED – The information be received.

# (iii) Asset of Community Value

The Chairman reported on further correspondence received from the co-owner of the Forge Public house.

This had been considered by Councillors and members had decided not to withdraw the application.

A letter had been received from County Council regarding the application and after consideration, they had decided that the building met the legal definition of 'community value' and therefore, it would be listed in the Public Register of Assets of Community Value for five years.
