15/24 Questions from Parishioners

Resident brought attention to the land at the back of the cricket club/tennis court area, very overgrown at present and asking for the area to be weeded and trimmed. 5/24 Cllr Scott advised following a conversation with Mr Clark. The site had never been refused caravans on site - the issue was the gate and access for caravans turning into the site from the main road. The gate has been moved which resolved the concerns of the caravan and camping club. The excess noise reported was related to grass cutting which was a one-off with extenuating circumstances.
