91/25 Questions from Parishioners

Concerns were raised regarding dogs on the park area in general, with particular emphasis on one dog that was not on a lead. This incident caused distress to a resident.

Residents raised concerns about the number of road traffic accidents. Whilst acknowledging that recent weather conditions have been poor, specific concern was noted at the corner from Woodlands entering the centre of the village. Existing bollards are not felt to provide sufficient protection for passing pedestrians. Can highways explore possible replacement or alternative safety measures? ACTION: Deb Wilson

Residents previous query re static buildings on campsite has yet to be answered. Original email to NCC 3rd December 2025 - chased 12th January 2026 - no response to-date.

Playing field trees are potentially become dangerous - around the playground equipment and near the boules area - hedges need trimming so that they remain manageable - resident volunteered to trim the hedge. ACTION: Cllr Scott
Cllr Scott advised the boundaries and fences are to be reviewed.

Graffiti is an ongoing issue, to be followed up. ACTION: D Wilson

Whilst it is taking time to assimilate the qualitative data, the tennis court was identified for discussion at the meeting.

There was discussion around the potential for a multipurpose covering which would allow the space to be used for activities beyond tennis. ACTION: Cllr Barton

As requested in the Parish Council email dated 19th December 2025. UCBS and Mrs Whelan's agent have re-established communications. Unfortunately, Mrs Whelan is currently very unwell so progress is likely to be limited for the time being, however discussions will continue as circumstances allow.

97/25 Precept and Budget

Further to the minutes of December 2025, Council was advised to delay submission of the precept form pending receipt of a revised tax base (Minute 84/25).

Under Option 3, the previously agreed increase for Band D properties was £1.28. Following application of the revised tax base, the increase under Option 3 is reduced to £1.15 per Band D property, with proportional adjustments applied by NCC to the remaining bands.

Council agreed the amended figures and resolved to submit the precept form to NCC by the deadline of 23rd January 2026.

102/25 Reports from Chairman and Members

Cllr Shaw raised an issue on behalf of a resident regarding the need for an additional grit box along the lane to Ulgham Park. Following discussion, it was agreed to look into installing a new grit box to be placed at the top of the hill near the location of the previous fallen tree, to help address ice on the hill down towards the river.

It was also requested that the grit bins across the village be checked and refilled as needed.

For council to look into purchasing a grit spreader

Copy of planning talk by Rob Murfin is still outstanding.

Cllr Scott raised concerns on behalf of a new resident to the village who is finding it difficult to exit their driveway onto the main road due to the speed of passing traffic. It was suggested that a permanent camera sign could be considered to help encourage drivers to slow down..

Ounces were also highlighted regarding poor lighting at the end of the village. This is something to be raised with NCC. Previous discussions have identified that the parish would be required to fund half the cost.
